BUSINESS ARISING FROM THE MINUTES

Minute 0635: BREAKS AND LENGTH OF DAYS FOR OFFICIALS

The proposed Guideline for length of days for officials and for promoters to provide breaks continues to be work in progress, with a detailed Discussion Paper presented for the Commissioners consideration, and further discussion will take place at the next AOC meeting in August.

Minute 0638: OFFICIALS ACTIVITY POST COVID-19

The Commission's Working Group continues to work on potential promotion activities to attract more officials to the sport.

Minute 0639: AWMC OFFICIALS EXCHANGE - SINGAPORE AND NEW ZEALAND

The Australian Women in Motor Sport (AWMC) presented a Women in Motorsport Officials Exchange Proposal, which it is presenting to the Motoring Australia Board, seeking AOC comments and support. The proposal was similar to that processed by the former Women of Australian Motor Sport that existed prior to the Commission being formed in 2019, with an exchange of officials between the Singaporean and Australian Grand Prix, and Supercar meetings in New Zealand and Australia.

Following the presentation and discussion the Commissioners supported the proposal.

Minute 0640: AWMC FEMALE CROSS DISCIPLINE PROGRAM

The Australian Women in Motor Sport (AWMC) presented a Women in Motorsport Officials Exchange Proposal, which it is presenting to the Motoring Australia Board, seeking AOC comments and support.

The Paper outlined that female race officials are strongly represented in administration at meetings but under-represented in most other roles and the proposal suggested female officials be given the opportunity to trial a broad range of roles during a race meeting, in:

- scrutineering;
- supply;
- stewarding;
- recovery;
- timekeeping;
- command - Assistant Clerk of Course.

Following the presentation and discussion the Commissioners supported the proposal.
