MATTERS ARISING AT MEETING

Min 0594 Contactless Rallying in a Covid19 Environment - Discussion Paper

A Decision Paper was submitted by IB, designed to assist in the reduction of physical contact for rally competitors and officials. After discussion it was recommended that IB's paper be forwarded to the Covid-19 Events Working Group set up within Administration at Motorsport Australia to review the recommendations and decide what implementations could be taken from it.

Min 0595: Strategic Plan – Sensible Safety - Discussion Paper

Discussion Paper was submitted coinciding with the sensible safety section of the strategic plan.

The paper recommended the addition of a further objective, to assist in the implementation of rally and road event safety related regulations by working with Motorsport Australia, the various State Rally Advisory Panels, and other advisory bodies to ensure that all stakeholders have access to supporting information and education on the reasoning and benefits of the proposed changes, and sufficient advance information to allow an orderly implementation.

Administration highlighted that numerous reports had been published and CAMS/Motorsport Australia had given competitors at least 12-months notice of any regulatory changes being proposed – which were published in Speed Read and on the Motorsport Australia website.
