## STEWARDS SUMMARY OF JUDICIAL OUTCOMES, Update 3: issued Sunday 11 July 2021 at 1845hrs.

### **Matters from Race 2:**

#### Race Director Incident Determinations

There were no determinations.

#### Stewards' Decisions – Penalties imposed

Following a review of the Broadcast footage, the Stewards in consultation with the DRD and DSA determined Car 30, Aaron Seaton in breach of Schedule B2 – Article 2.1.1 Careless Driving. Car 30 made contact with Car 6 at Turn 2 on Lap 2 resulting in Car 6 retiring from Race 2. The Stewards imposed a penalty of Loss of 25 Driver Championship Points on Car 30.

Following a request for an investigation from MW Motorsport alleging Car 49 made contact with Car 27 on Lap 10 at Turn 2 resulting in loss of a position by Car 27. Following a review of the Broadcast footage the Stewards determined a breach of Schedule B2 – Article 2.1.1 Careless Driving Careless Driving. The Stewards imposed a Post-Race Time penalty of 5 seconds on Car 49.

The Stewards imposed a 5 Grid Penalty in Race 2 on Car 35, Jason Gomersall for a Breach of Schedule B2 Article 2.1.1 Careless Driving, departing from the Standard of a competent Driver. Car 35 caused contact with Car 39, Chris Smerdon in Race 1 at Turn 11 on Lap 9 resulting in Car 39 losing several positions.

Stewards' Decisions – Penalties imposed

The Stewards received reports from the Race Director and after reviewing Timing Data imposed the following penalties

- A fine of \$500 wholly suspended until 31/12/2021 was imposed on Car 69, Jon McCorkindale for a breach of Rule D11.5.10.3 by returning to Pit Lane after the chequered flag was displayed.
- A fine of \$500 was imposed on Car 5, Michael Anderson for a breach of Rule D11.5.10.3 by returning to Pit Lane after the chequered flag was displayed and a breach of Rule D11.5.10.1 for working on the car after the chequered flag was displayed.

Stewards' Decisions – Penalties imposed

The Stewards imposed a \$500 fine on Car 39, Chris Smerdon for a breach of Rule D11.4.2 Speed Limit, exceeding the Pit Lane Speed Limit at Pit Entry. The recorded speed was 51km/h.
